Sample SMART goals:

- By the end of the 2018-2019 school year, at least 50% of students will have participated in at least one transition activity (i.e. business tour, Amazing Race, college visit) as outlined by their Postsecondary Transition Plan (PTP).
- By the end of the 2018-2019 school year, at least 60% of students will have participated in at least one college tour.
- Special Education teachers will complete at least two hours of professional development around the PTP plan by January 2019.
